## **Data Submission Purpose**

#### **PEIMS**

The data is used to identify the Education Organization, Finance, Staff, Student information in the data reports and analysis that are performed by the Texas Education Agency. This includes, but is not limited to, PEIMS reports, AEIS/Accountability ratings, and funding calculations.

### **Data Submission Requirements**

Local education agencies (LEAs) and Education Service Centers will transmit their PEIMS data collection to the Education Data Warehouse (EDW) using one or more Interchange Schemas drawn from the Ed-Fi Core and Texas Core Extension Schemas. LEAs are urged to think of PEIMS reporting requirements in terms of the transmission of sets of data rather than sending fixed column records. Data extracted from the LEA data systems(s) must be formatted according to the Texas Education Data Standards (TEDS) for submission purposes. Every LEA in the state will use the same XML formats to submit data. The LEA's data will be loaded to the Education Data Warehouse (EDW) where it will be subject to the business rules and validations prior to being certified by the LEA superintendent.

This section includes the Ed-Fi Core and Texas Core Extension Complex Type formats, which describe the contents of a particular Complex Type and the data elements that are required. Business rules, reporting requirements, and examples are also provided.

#### This section includes:

 Complex type data layouts, which show the relationship of data submissions to category types. Also described, for each category type, is information on data submission for the current school year for both LEAs submission of data to the ESCs and ESCs submission of data to TEA;

Asterisks (\*\*) that appear in the complex type data layouts indicate that there is a complex type within a complex type. The Element Ids that are indented identify the data elements that are part of the complex type denoted with asterisks (\*\*).

Data rows that are in gray and italicized represent interchange schemas, complex types and data elements that are a part of the Ed-Fi Core Schema, but not for Texas use at this time.

- Category type discussions which describe information related to each particular record type;
- Data submission samples, which provide samples of how to submit the data for each category.

#### **PEIMS**

PEIMS data consists of five categories: education organization, finance (budget, payroll, and actual), campus course section, staff, and student.

Local education agencies (LEAs) and Education Service Centers (ESCs) will transmit their PEIMS data collection to the Education Data Warehouse (EDW) using one or more Interchange Schemas drawn from the Ed-Fi Core and Texas Core Extension Schemas. LEAs are urged to think of PEIMS reporting requirements in terms of the transmission of sets of data rather than sending fixed column records.

These interchange schemas are mandatory for data submission for each local education agency (LEA), and education service centers (ESCs) when submitting PEIMS data to the Texas Education Agency (TEA). Throughout the TEDS documentation, local education agencies will be referred to as LEAs. Education service centers will be referred to as ESCs.

Data extracted from a LEAs student information system (SIS), whether automated or not, must be formatted according to the specified interchange schema for each PEIMS submission. Every LEA and ESC in the state will use the same record layout to submit data, regardless of the degree of sophistication of its SIS and/or data processing facility.

The school district's data files will be processed through the PEIMS data editor when loaded to the EDIT+ system at the Texas Education Agency (TEA). All fatal errors that are identified must be corrected before the TEA will accept a LEA or ESC's PEIMS data. Special warning and warning edits must be reviewed for data accuracy by the appropriate LEA and ESC staff before the data is approved by the same.

PEIMS data is collected four times each school year. The collections are Submission 1 (Fall Snapshot (including student leaver) data), Submission 2 (Mid-Year (prior year financial actual) data), Submission 3 (Summer (school year attendance) data), and Submission 4 (Extended Year (summer program) data).
