Texas Student Data System (TSDS) Education Data Warehouse (EDW) Vision

For over 20 years, Texas has performed thorough data collections to support state and federal reporting and policy efforts. As a result, many of the required data elements for a statewide longitudinal data system are currently in place. However, the systems were not developed to support more recent demands for timely, transparent, accessible, and immediately actionable data back to stakeholders.

The TEA data management environment is currently focused on meeting state and federal compliance reporting requirements. A district-facing data warehouse will make near real time, actionable data available to educators and relevant stakeholders.

The Texas Education Agency collects organization, budget, actual financial, staff and student data for approximately 1,235 school LEAs, 8,711 campuses, and over 4.6 million students in the Texas public school system. The vast majority of Texas LEAs serve fewer than 5,000 students, and many of these LEAs have difficulty providing budgets and staff to support even basic local information technology efforts.

The complexity of the state reporting process places great demands on local administrations. By providing a district-facing data warehouse, these state reporting needs can be met more transparently, using data that LEAs would already provide for the warehouse.

The anticipated outcome of the Texas Student Data System (TSDS) Education Data Warehouse (EDW) solution is the expansion of the current information management environment from a point-in-time data collection and reporting environment to a timely and dynamic environment that will:

- Enable continuous improvement of student performance through performance-based reporting
- Alleviate the data collection burden on LEAs
- Improve data quality

Early Childhood Data System (ECDS)

Early Childhood Data System (ECDS) is the collection of both Pre-Kindergarten and Kindergarten student data, which includes both student demographic and assessment data.

ECDS is formerly known as the Kindergarten Readiness System (KRS). KRS data was previously collected using a now obsolete application called OZ Systems.

ECDS is the first of several state and federal reporting collections that will be integrated into TSDS.

Why TEA Collects ECDS Data

ECDS is collected to certify the effectiveness of childcare programs in preparing children for kindergarten. The following is a list of those programs:

- Non-Public Pre-K Head Start
- Public Pre-K Licensed Child Care Programs
- Non-Public Pre-K Licensed Child Care
- Public Pre-K Head Start
- Public Pre-K Licensed Child Care
- Other

ECDS Kindergarten data is mandated by the Texas Legislature in the following Texas Education Codes (TEC).

Legislative Background

TEC Sec. 29.161. SCHOOL READINESS CERTIFICATION SYSTEM.

The State Center for Early Childhood Development, in conjunction with the P-16 Council established under Section 61.076, shall develop and adopt a school readiness certification system for use in certifying the effectiveness of prekindergarten programs, Head Start and Early Head Start programs, government- subsidized child-care programs provided by nonprofit or for-profit entities, government-subsidized faith- based child-care programs, and other government-subsidized child-care programs in preparing children for kindergarten. The system shall be made available on a voluntary basis to program providers seeking to obtain certification as evidence of the quality of the program provided.

- (a) In developing and adopting the system, the center shall seek the active participation of all interested stakeholders, including parents and program providers.
- (b) The system must:
 - (1) be reflective of research in the field of early childhood care and education;
 - (2) be well-grounded in the cognitive, social, and emotional development of young children;
 - (3) apply a common set of criteria to each program provider seeking certification, regardless of the type of program or source of program funding; and
 - (4) be capable of fulfilling the reporting and notice requirements of Sections 28.006(d) and(g).
- (c) The agency shall collect each student's raw score results on the reading instrument administered under Section 28.006 from each LEA using the system created under Subsection (a) and shall contract with the State Center for Early Childhood Development for purposes of this section.
- (d) The State Center for Early Childhood Development shall, using funds appropriated for the school readiness certification system, provide the system created under Subsection (a) to each LEA to report each student's raw score results on the reading instrument administered under Section 28.006. The agency shall:
 - (1) provide assistance to the State Center for Early Childhood Development in developing and adopting the school readiness certification system under this section, including providing access to data for the purpose of locating the teacher and campus of record for students; and
 - (2) require confidentiality and other security measures for student data provided to the State Center for Early Childhood Development as the agency's agent, consistent with the Family Educational Rights and Privacy Act of 1974 (20 U.S.C. Section 1232g).

Kindergarten

TEC28.006(c)–READINGDIAGNOSIS

Each LEA shall administer, at the kindergarten and first and second grade levels, a reading instrument on the list approved by the commissioner or by the LEA-level committee.

The LEA shall administer the reading instrument in accordance with the commissioner's recommendations under Sub-section(a)(1).

TEC28.006(d) The superintendent of each LEA shall:

- (1) Report to the commissioner and the board of trustees of the LEA the results of the reading instruments;
- (2) Report, in writing, to a student's parent or guardian the student's results on the reading instrument; and
- (3) Using the school readiness certification system provided to the LEA in accordance with Section 29.161(e), report electronically each student's raw score on the reading instrument to the agency for use in the agency for use in the school readiness certification system

TEC28.006(d-1) The agency shall contract with the State Center Early Childhood Development to receive and use scores under Subsection (d)(3) on behalf of the agency.

Pre-Kindergarten:

TEC Sec. 29.1532. PREKINDERGARTEN PROGRAM REQUIREMENTS:

- (a) An LEA's prekindergarten program shall be designed to develop skills necessary for success in the regular public school curriculum, including language, mathematics, and social skills.
- (b) If an LEA contracts with a private entity for the operation of the LEA's prekindergarten program, the program must at a minimum comply with the applicable child-care licensing standards adopted by the Department of Protective and Regulatory Services under Section 42.042, Human Resources Code.
- (c) An LEA that offers prekindergarten classes shall include the following information in the LEA's Public Education Information Management System (PEIMS) report:
 - (d) demographic information, as determined by the commissioner, on students enrolled in the information, as determined by the commissioner, on students enrolled in the LEA's prekindergarten classed, including the number of students who are eligible for classes under Section 29.153;
 - (e) the numbers of half-day and full-day prekindergarten classes offered by the LEA; and
 - (f) the sources of funding for the prekindergarten classes.

Purpose of ECDS

To inform parents, school administrators, the public, statewide stakeholders, the early childhood education community, and policy makers about the quality of early childhood education and direct resources in an informed manner.

Who Reports ECDS Data

Kindergarten ECDS data reporting is mandatory. The data collection includes student demographics and assessments. LEAs who administer the Commissioner's List of Reading Instruments are required to collect and report this data.

Pre-Kindergarten ECDS data reporting is optional. The data collection includes student demographics. This data is submitted by Public & Private Pre-Kindergarten Programs.

Exemption

LEAs administering an assessment that is not compatible with ECDS as described in the 'To The Administrator Addressed' letter will notify the TEA program area of the type of assessment used, and the LEA will be responsible for retaining the data should TEA decide to collect at a later date.

Reporting ECDS to TEA

Interim Solution

Data for both Pre-Kindergarten and Kindergarten will be documented by LEAs using MS Excel templates. The 2015-2016 MS Excel Templates are located as follows:

An XML converter is provided by TEA for LEAs to convert data from MS Excel to the TEDS Compliant Interchange XML files.

XML files will be loaded either manually in the eDM or by using the Data Transfer Utility (DTU). These MS Excel templates will be supplied until all LEAs are loading data to the EDW through the XML interchanges.

Early Adopters of TSDS who report ECDS data will use the TSDS Collection for reporting. If the LEA does not have their assessments in the TEDS Compliant format, they will be able to use the MS Excel templates for just reporting the Kindergarten assessment data.

Permanent Solution

The TSDS Collection will be used by LEAs for required state and federal reporting and the optional studentGPS® Dashboards.

ECDS is the first state data collection reported using the TSDS collection.
