Texas Student Data System Community and Student Engagement Data Collection Overview

The Community and Student Engagement (CASE) and Compliance indicators are legislated in Texas Education Code (TEC) 39.0545 and 39.0546. Annually, and near the end of each school year, each local education agency (LEA (school districts and open enrollment charter schools)) and the instructional campuses associated with each are required to determine the ratings for each of the ten (10) CASE indicators as applicable to the LEA and campuses. These CASE and Compliance indicators are then reported to the Texas Education Agency (TEA) who then posts the information for each LEA and campus to the TEA public website as required by statute.

Additionally, the CASE indicators are legislated in TEC 39.053 to be included in the state of Texas public school accountability ratings beginning with the 2017-2018 school year as part of Domain Five. LEAs and the campuses associated with each LEA are required to select three (E1575-E1577) of the eight CASE indicators (E1531-E1538) to be utilized in the Domain Five accountability ratings computation prior to the school year that the accountability ratings will be computed. Also, the LEAs and campuses are required to an internet webpage link that documents the criteria that will be used the following school year to rate the organizations on the CASE indicators. These three CASE choices and the CASE ratings criteria internet link are due with the Summer PEIMS submission starting with the 2016-2017 school year.

The Texas Juvenile Justice LEA/campuses, juvenile justice alternative education program (JJAEP) campuses, disciplinary alternative education (DAEP) campuses, and juvenile detention center campuses are exempt from all of the requirements related to reporting the CASE indicator codes. All other LEA and campus not specifically exempted are required to report the CASE data specified below.

Data Submission and LEA Management Responsibilities

The reporting of the CASE data collection has two purposes. The first is to comply with the TEC 39.0545 requirement that each applicable LEA and campus evaluate themselves on each of the ten (10) CASE indicators and second that that the LEA/campus(es) provide the data required by TEC 39.053 for Domain Five accountability ratings.

The superintendent of each LEA is responsible for ensuring that the TSDS CASE data submission is completed by the due dates stated above to avoid the LEA and/or campus(es) being penalized in Domain Five of the Texas public school accountability ratings system and to avoid the data for all of the CASE ratings being missing in the required state reporting of the CASE indicators. The TSDS CASE collection does not utilize the traditional PEIMS submission and resubmission concepts. Unlike the traditional PEIMS submissions where there is a submission due date and then a resubmission due date, the TSDS CASE data must be submitted by the stated due date with no resubmission opportunity available. **If the CASE data for a LEA or campus associated with the LEA is not reported by the stated due dates, the CASE data will not be included in the Domain Five ratings for the LEA and/or campus(es) and will not be included in the TEA reporting of the CASE indicators for the LEA/campus(es).**

Texas Student Data System Community and Student Engagement Data Collection

Reporting the CASE data indicators is a multi-submission process.

At the end of each school year and prior to the school year in which the ratings will be collected, LEAs and campuses are required to submit through PEIMS Submission 3 (Summer Submission) the three CASE indicators that the LEA and campuses will be rated on in Domain 5 of the following school year accountability ratings. These three selections can be different for the LEA and each of the campuses.

In addition to selecting and reporting the three case indicators that each LEA and campus will be included in Domain 5, the criteria by which the LEA and campuses will be rated locally must be provided to TEA. These ratings criteria must be submitted in the form of an internet link to a webpage.

If after the three selected CASE ratings are reported to TEA in Submission 3, administration at the LEA superintendent or campus principal changes, no changes can be made to the CASE ratings that were selected by the previous administrator(s) and the new superintendent and/or principal must wait until the end of the school year to select different CASE ratings choices for the next year accountability ratings.

For example, Texas ISD has five (5) campuses; Texas High School, Texas Middle School, Texas Elementary School, Texas DAEP, and Texas JJAEP. At the end of the 2016-2017 school year, Texas ISD superintendent and Principals selected the following CASE codes to be used in the 2017-2018 accountability ratings for Texas ISD.
