## **2019-2020 TSDS Data Collection Requirement Changes**

The Texas Education Agency (TEA) is amending the TSDS system to collect the Expanded Learning Opportunity (ELO) types, the ELO offerings by each campus/school, and the ELO offerings that each student participated in at each campus the student was enrolled during a particular school year.

The reporting changes for the ELO data collection are based on Senate Bill 1404 (85<sup>th</sup>). The legislation expands the requirements of existing legislation related to the availability of and participation in expanded learning opportunities by adding a data collection requirement in Texas Education Code (TEC) 42.006(a-2).

Under the statute, each LEA is required to report for each campus or school the availability of ELOs as described by TEC 33.252(a) and the number of students at each campus participating in once or more of the categories of ELOs listed under TEC Section 33.252(b).

TEC 33.252(a) explains that expanded learning opportunities may be provided during:

1. an extended school day;
2. an extended school year; or
3. structured learning programs outside of the regular school day, including before and after-school programs and summer programs.

TEC 33.252(b) describes the campus or school offerings within each ELO delivery method for student participation as:

1. rigorous coursework;
2. mentoring;
3. tutoring;
4. physical activity;
5. academic support; or
6. educational enrichment in one or more subjects, including fine arts, civic engagement, science, technology, engineering, and mathematics.

To implement the ELO data collection, the following changes will be implemented for the 2019-2020 school year TSDS PEIMS data collections as part of the Summer Submission (Submission 3) and the Extended Year Submission (Submission 4):
